Sri Dillip Kumar Chhotray, Ex-Dy. Director, Public Prosecution (Retd.) is re-engaged temporarily as a Consultant to act as Deputy Director (Training & Academics) in State Vigilance Academy, Bhubaneswar under G.A (Vigilance) Department for a further period of one year from the date of his actual joining with consolidated remuneration of Rs.60,000/- (Rupees Sixty thousand) only per month.

The terms and conditions under which Sri Chhotray shall be engaged are as follows:

1. The period of his engagement shall not be counted as Government service for the purpose of pension or any other retirement benefit.
2. He will not get any other facilities and perquisites except the monthly consolidated remuneration.
3. The expenditure in this respect shall be borne by GA (Vigilance) Department out of the budgetary provision under "Demand No.2-2062-OAS-105-Dist. Estt.-0308-02007- Consolidated Pay for Contractual Appointees".
4. This has been approved by Government vide UOR No.155/CMS dt.06.12.2018, concurred in by Finance Department vide G.A. & P.G. OSWAS File No.GAD-BUD-GEN-0012-2019 and agreed by G.A. & P.G. Department vide UOR No.166/G.A. & P.G. dtd-16.11.2019.
