Shri Rabindra Kumar Dash, OPS(I), Retd. S.P., Special Branch, Bhubaneswar is engaged temporarily as a Consultant to act as Registrar in State Vigilance Academy, Bhubaneswar under G.A (Vigilance) Department for a period of 2(two) years from the date of his actual joining with a consolidated remuneration of Rs.30,000/- (Rupees Thirty Thousand) only per month as per F.D. O.M No.7022/F dt.17.03.2018. Besides remuneration, Shri Dash shall not be extended with any other financial benefits.

This has been approved by Government vide their UOR No.29/CMS dt.28.02.2019 and concurred in by Finance Department on 02.07.2019.

Besides, the terms and conditions under which Shri Dash shall be engaged are as follows:

1. The period of his engagement shall not be counted as Government service for the purpose of pension or any other retirement benefits.
2. The expenditure in this respect shall be borne by GA (Vigilance) Department out of the budgetary provision under "Demand No.2-2062-OAS-105-Dist. Estt.-0308-02007- Consolidated Pay for Contractual Appointees".
3. His engagement can be terminated at any time by the Director, Vigilance on grounds of unsatisfactory performance or in case of any misconduct, misappropriation, negligence or causing loss to the Government or any breach of conduct or indictment in a Court of law, by giving one month notice. Such termination of engagement may debar him from further engagement in this Department. Conversely, if he desires to resign, he can do so by giving one month written notice to the Director, Vigilance.






